3 IT IS FURTHER ORDERED that the Receiver, upon receipt of a sworn statement by
4 an annuitant that the annuitant is in need of the annuitant's scheduled annuity payments in
5 order to pay for rent, food or other necessities of life, which statement is supported by a
6 sworn financial statement satisfactory to the Receiver, the Receiver may make up to four
7 monthly annuity payments to such annuitant, provided no such payment shall be made to the
8 extent that it would result in the annuitant receiving total payments of more than 15% of the
9 amount originally invested.
